## Athlete Membership Application

### If you register for the first time:

To receive your passbook to box, the following items must accompany your athlete membership application form:

- ► Completed athlete membership application form, signed by your parent or legal guardian. Cannot be signed by a coach or other person.
- ► Two (2) photographs 1 ½ X 1 ½ inches above the shoulder shots.
- ▶ Birth verification (a certified copy of birth certificate, certified by Notary Public, in its absence, a baptismal or hospital record) from the state, county, Municipal Bureau of Vital Statistics or local jurisdiction of the place of birth.
- ► Membership application fee.

#### If you are renewing your membership:

- ► Completed athlete membership application form, signed by your parent or legal guardian. Cannot be signed by a coach or other person.
- ► Membership application fee.
- Passbook.

In each case, the athlete membership application form must be filled out in its entirety and signed by the applicant. If the applicant is under the age of 18, it must be signed by his/her parent or legal guardian only. No other person may sign for the parent or legal guardian.

Restricted Participation (Article I, 101.9(2) Foreign Athletes: Foreign athletes are barred from participation in advancing local, regional and national tournaments or any box-offs that would lead to international competition.
